Subject : Template NOTAM for reduced services at aerodromes due to COVID-19

Dear Madam/Sir,

- 1. I wish to turn to a recent example whereby ATS in oceanic airspace were temporarily reduced due to an ACC being vacated, and the NOTAM proved confounding to Operators and neighboring ANSPs alike. In this regard, I wish to reiterate the importance of *ATM Contingency Plans* should reduction in air traffic services become unavoidable, and invite you to consider the following subjects when drafting NOTAM:
 - The extent air traffic services will be provided (ATC, flight service, alerting service), or no service procedures.
 - Airspace that the contingency plan applies to.
 - Any revision to airspace classification
 - Implementation of Traffic information broadcast by aircraft (TIBA) or the IATA In-flight Broadcast Procedure (IFBP), including Frequency to be used.
 - Procedures for re-entering controlled airspace, if necessary
 - Revised communications procedures
 - Availability of ATS surveillance service
 - Reference to promulgated Regional procedures and guidance material and promulgation of pertinent aspects, if considered essential.
 - Reference to other pertinent procedures in PANS-ATM 15.2.3.3 where clearance cannot be obtained and pilot needs to exercise the authority of a pilot-in-command under the provisions of Annex 2, 2.3.1.
 - Responsibilities of adjacent ANSPs
 - Contingency tracks
 - Separation standards
 - Air traffic flow management procedures
- 2. Finally, attached herewith you shall find a draft NOTAM that your ANSP might find useful for promulgating reduced services at international aerodromes.
